### INFORMATION PURSUANT TO ARTICLE 13 - ITALIAN LEGISLATIVE DECREE NO. 196/2003

In compliance with the provisions of Article 13 of the Italian Legislative Decree no. 196 of 30 June 2003, Personal Data Protection Code (Codice in materia di protezione dei dati personali), herewith to inform you that ASSOCIAZIONE CULTURALE "IL CIRCOLO" carries out the processing of personal data fully respecting the Italian Legislative Decree no. 196/03. Under those provisions, the processing will be in accordance with the principles of fairness, lawfulness and transparency, and of protection of confidentiality and of rights.

Pursuant to Article 13 of the Italian Legislative Decree no. 196/2003 we inform you that:

- ✓ the information you provide will be processed for the execution of contractual, legal and fiscal obligations;
- ✓ we will use your data both manually and with the electronic means aid, or however with automated means, in the respect of the conditions of the Law;
